By-Law Number 22-2008

Being a By-law to adopt a Municipal Alcohol Policy

WHEREAS Section 10 of the Municipal Act, 2001 provides that a municipality may pass by-laws respecting matters such as protection to persons and property, and the health, safety, and well-being of persons;

AND WHEREAS Council deems it necessary to adopt a Municipal Alcohol Policy for the management of alcohol usage and special occasion permit events on properties and in facilities owned by the municipality;

AND WHEREAS the Corporation of the Township of Killaloe, Hagarty and Richards deems it in the public interest to enact this by-law;

NOW THEREFORE the Council of the Corporation of the Township of Killaloe, Hagarty and Richards enacts as follows:

- 1. The Council for the Township of Killaloe, Hagarty and Richards hereby adopts the Municipal Alcohol Policy provided as Schedule "A" attached hereto.
- 2. This by-law shall come into force and take effect upon final passage thereof, and replaces By-Law 17-2002.

Schedule "A" to By-Law 22-2008

Reasons for enacting a Municipal Alcohol Policy

- 1. The prevention of alcohol related problems on properties and in facilities owned by the Municipal Corporation of the Township of Killaloe, Hagarty and Richards.
- 2. The reduction of the risk to the Municipal Corporation of the Township of Killaloe, Hagarty and Richards, and hence to the taxpayers of civil liability as a result of alcohol use.
- 3. The promotion of a safe and enjoyable environment for those who use properties and facilities owned by the Municipal Corporation of the Township of Killaloe, Hagarty and Richards.

In this policy the following definition applies to Alcohol

- means spirits, wine or beer, or any combination thereof and includes any product of fermentation or distillation in a form appropriate for human consumption as a beverage, alone or in combination with another matter.

Special Occasion Permit Events

- Requests for events requiring a Special Occasion Permit on municipal property or in municipal facilities must be submitted to council prior to the event, and will be subject to council approval on an individual basis.

Youth Events

- All events involving predominately minors, (i.e. the majority of the participants being under the legal drinking age) are designated as not suitable for Special Occasion Permits.

Signage

- Notification "NO ALCOHOL PERMITTED ON TOWNSHIP PROPERTY"
- This sign is to be posted in the following locations:
- 1. Sheryl Boyle Park 3 Deer Trail Road
- 2. Round Lake Recreation Facility 43 Rink Road
- 3. Killaloe Station Park 167 Queen Street
- 4. Killaloe Outdoor Rink 28 Cameron Street
- 5. Hoch Park 86 Queen Street
- 6. Municipal Office 1 John Street
- 7. Killaloe Fire Hall 5 Civic Street
- 8. Round Lake Fire Hall 2995 Round Lake Road
- 9. Killaloe, Hagarty and Richards Works Buildings 16370 Hwy. 60

Signs of this nature will indicate that the use of alcohol in non-licensed areas will not be allowed.

Individuals and/or groups who fail to comply with the Municipal Alcohol Policy shall be subject to the following consequence:

The municipal representative or municipal staff or designate may report any infraction of this policy to legal authorities whenever they believe such action is required.

Policy Monitoring and Revisions:

- This policy will be reviewed on a regular basis by the Council for the Township of Killaloe, Hagarty and Richards.
