# Being a By-law to adopt a Municipal Alcohol Policy

WHEREAS Section 102 of the Ontario Municipal Act, R.S.O. 1990 provides that every Council may pass such by-laws, and make such regulations for the health, safety, morality and welfare of the inhabitants of the municipality;

AND WHEREAS Council deems it necessary to adopt a Municipal Alcohol Policy for the management of alcohol usage and special occasion permit events within the township parks and recreation facilities;

AND WHEREAS the Corporation of the Township of Killaloe, Hagarty and Richards deems it in the public interest to enact this by-law;

NOW THEREFORE the Council of the Corporation of the Township of Killaloe, Hagarty and Richards enacts as follows:

- 1. Council hereby adopts the Municipal Alcohol Policy provided as Schedule "A" attached.
- 2. This by-law repeals By-Law 11-2000.

# Reasons for enacting a Municipal Alcohol Policy

- 1. The prevention of alcohol related problems on Killaloe, Hagarty and Richards Township properties.
- 2. The reduction of the risk to the Township and hence to the taxpayers of civil liability as a result of alcohol use.
- 3. The promotion of a safe and enjoyable environment for those who use township properties and facilities.

#### In this policy the following definition applies to Alcohol

- means spirits, wine or beer, or any combination thereof and includes any product of fermentation or distillation in a form appropriate for human consumption as a beverage, alone or in combination with another matter.

#### **Special Occasion Permit Events**

- Requests for events requiring a Special Occasion Permit on municipal property must be submitted to council prior to the event, and will be subject to council approval on an individual basis.

#### **Youth Events**

- All events involving predominately minors, (i.e. the majority of the participants being under the legal drinking age) are designated as not suitable for Special Occasion Permits. These events are intended for young people. Nonconsumption by participating adults provides leadership by example.

### Signage

- Notification "NO ALCOHOL PERMITTED ON TOWNSHIP PROPERTY"
- This sign is to be posted in the following locations
- 1. Sheryl Boyle Park
- 2. Round Lake Rink
- 3. Station Park
- 4. Killaloe Outdoor Rink
- 5. Hoch Park

Signs of this nature will indicate that the use of alcohol in non-licensed areas will not be allowed.

# Individuals and/or groups who fail to comply to the Municipal Alcohol Policy shall be subject to the following consequence:

The municipal representative or municipal staff or designate may report any infraction of this policy to legal authorities whenever they believe such action is required.

#### Policy Monitoring and Revisions

This policy will be reviewed annually by the Recreation Committee. Based on information provided by the Recreation Committee and other interested parties, revisions to the policy will be forwarded to Council as suggestions in writing, for Council's approval.
