TOWNSHIP OF KILLALOE, HAGARTY AND RICHARDS

BY-LAW NO. 8-2005

Being a by-law to establish a reduced load period in the Township of Killaloe, Hagarty and Richards;

WHEREAAS Section 122(7) of the Highway Traffic Act, R.S.O. 1990, c.H.8, as amended provides that the Municipal Corporation or other authority having jurisdiction over a highway may by by-law designate the date on which a reduced load period shall start or end and the highway or portion thereof under its jurisdiction to which the designation applies;

AND WHEREAS the reduced load period is deemed necessary for the protection of certain highways within the Township of Killaloe, Hagarty and Richards;

NOW THEREFORE the Council for the Corporation of the Township of Killaloe, Hagarty and Richards enacts as follows:

- 1. (a) The provisions of Sections 122, 124, 125, 126 and 127 of the Highway Traffic Act, R.S.O. 1990, c.H.8 apply to the highways outlined in Schedule "A" hereto attached and forming part of this by-law, during the period from the first (1st) day of March or earlier if conditions warrant, to the fifteenth (15th) day of May, inclusive, or later, if conditions warrant, in each and every year.
 - (b) The Works Superintendent for the Township of Killaloe, Hagarty and Richards, or his/her designate, shall be responsible for determining when signage is to be erected and taken down, subject to the provisions outlined in 1 (a) above.
- 2. Any person violating the provisions of this by-law shall be subject to the penalties provided for in Sections 124(6)(7), 125, 126 and 127 of the Highway Traffic Act, R.S.O. 1990, c. H.8, and all such penalties shall be recoverable under the Provincial Offences Act.
- 3. This by-law shall come into effect upon final passage thereof, and upon the erection of appropriate signs in accordance with the regulations of the Highway Traffic Act, R.S.O. 1990, c. H.8.
- 4. This by-law replaces by-law # 09-2001 of the Township of Killaloe, Hagarty and Richards.
