Regular Meeting

The Council for the Township of Killaloe, Hagarty and Richards met on the above date with Councillors Ted Browne, John Jeffrey, Brian Pecoskie, Stanley Pecoskie, Carl Kuehl and Debbie Peplinskie present. Mayor Janice Visneskie Moore chaired the meeting, which she opened and called to order.

<u>Pecuniary/Financial Interest</u>: No pecuniary/financial interest was declared by any of the Council members present.

Minutes:

Motion to approve the minutes of the Regular Meeting of July 18, 2017, Open and Closed sessions.

Reports:

Acting Community Development Officer: Acting Community Development Officer Bonnie Ivimey reported on upcoming events, including the ongoing Songs from the Park in Station Park, Party in the Park on August 13, 2017 and An Irish Gathering from August 17-20, 2017. The BBQ for the swim program will be held on August 11th. Council gave Ms. Ivimey direction with regard to getting the fountain ready for An Irish Gathering. Ms. Ivimey advised that the Communications and Marketing Summer Student had delivered flyers for the Party in the Park, along with a donation request for items to give to the drivers of the antique cars that will be on display during the event. Council thanked Ms. Ivimey for her report, at which time she left the meeting.

Works Superintendent: Works Superintendent Dean Holly was present and gave his report. The sidewalk plow is broken, so the brushing attachment cannot be used at this time. Someone is coming in this week to look at it. The paving project on Mill Street in Killaloe will start after the Civic Holiday week-end. Councillor Browne advised that he had inquired about the trees that require pruning, and the ones in Station Park can be trimmed any time but the others need to be pruned in the winter. Mayor Visneskie Moore reported that she had attended the RLPOA AGM, and that she had received very positive feedback with regard to the assistance that the waste site staff had provided when dealing with the disposal of flood debris.

Submissions that had been received for Tender 04-2017, hot mix pave for a section of Turners Road and the stub at the intersection of Foy Park Corridor and Round Lake Road were opened by Mayor Visneskie Moore.

Council agreed to install additional No Parking signs, and to contact Jason Mask, Park Superintendent to advise him of the parking issue and ask that park staff monitor it as well.

Councillor Jeffrey advised that he had received positive feedback with regard to the brushing that has been done on the township's roads. The Works Superintendent advised that the RFP for the C&D grinding contract has been prepared and will be sent out to contractors, with a return date of August 22, 2017.
