New Business:

Council reviewed the draft by-law and policy that the CAO/Clerk-Treasurer had prepared for assistance with damage to private roads due to a declared emergency. Council will let the CAO/Clerk-Treasurer know if any amendments are required prior to passage.

Councillor Stanley Pecoskie asked for and received council volunteers for assistance with the upcoming HHW day on August 19, 2017.

Council asked the CAO/Clerk-Treasurer to have the Acting Community Development Officer arrange for the annual pizza lunch for the summer students with Mayor Visneskie Moore on August 25th.

Councillor Kuehl asked that the CAO/Clerk-Treasurer ask the Works Superintendent to ensure that the front entranceway is cleared of spider webs and scrubbed, while the summer students are still here.

Councillor Stanley Pecoskie advised that Brian King from GFL had submitted a price of \$1000/load for trucking flood debris to their facility in Moose Creek, and that Works Superintendent Dean Holly has estimated that there are about 6 loads of debris to be hauled.

Councillor Stanley Pecoskie also advised that he had been contacted by Terry Laginskie with regard to a key for the lock on the gate at the old rink road, as the one that was given to Jerome Laginskie several years ago could not be located. As this is the access to property owned by Christine Laginskie, Council agreed to give her a key.

Mayor Visneskie Moore advised that she had received a letter from Dave Mayville on behalf of Round Lake Recreation, asking if Council would agree to pay for a swing set that they had purchased for Sheryl Boyle Park, as they were able to get a better deal when they bought two. The committee had agreed to purchase one, and that has been installed at the Round Lake Recreation Park. Pursuant to a previous request of the committee, Council had agreed to pay the invoice for the swing set that was being purchased for the Round Lake Recreation Park, and then invoice the Round Lake Recreation Committee for the swing set, minus the HST refund that the municipality receives. Council did not approve the request to purchase the swing set for Sheryl Boyle Park, but agreed that this purchase could also be paid by the township and invoiced, net of the recoverable HST, to the Round Lake Recreation Committee.

Councillor Jeffrey advised that an entranceway has been installed on Tramore Road without a permit, and that the location would not meet the site line criteria for entranceways. Council asked Councillor Jeffrey to have the Works Superintendent conduct a site visit, and if no permit was issued, and if the driveway is located in an unsafe location, he is to remove it.
