The Council for the Township of Killaloe, Hagarty and Richards met on the above date with Councillors Isabel O'Reilly, Kathy Marion, Ernie Cybulski, Stanley Pecoskie, Carl Kuehl and Debbie Peplinskie present. Mayor Janice Visneskie chaired the meeting, which she opened and called to order.

Mayor Visneskie reported that she had met with representatives from the Round Lake Property Owners Association, the Golden Lake Property Owners Association, and Renfrew Hydro about issues relating to damage caused by the increase in water levels in Round Lake and Golden Lake, and the related shoreline ice damage. Mayor Visneskie will sit on the committee which has been formed in an attempt to collectively find a solution to this ongoing problem. Councillor Cybulski will be her alternate for this committee. The next meeting is scheduled for January 2010.

# **Committee Reports:**

**Waste Management Committee:** Councillor Cybulski reported that, since the tender for grinding the C & D waste had been awarded, a large amount of additional material has been brought into the waste site. The contractor has requested an additional \$3,000 to grind this material. Council approved this request.

She advised that a discussion had been held in regard to the amalgamation of the Round Lake Recreation Committee and the Friends of the Killaloe Rink, but that Tim Summers had told the committee that, as their committee currently has charitable, non-profit status, it would be very difficult to retain this status if other groups are added to the committee. Amalgamation could also affect their ability to obtain grants.

Councillor O'Reilly outlined the activities which are planned for the Sno-Fun Week-End, February 3, 2010 to February 7, 2010. She also advised that Tim Summers had indicated at the meeting that the focal point of this event should remain in Killaloe, and not be spread throughout the township.

**Finance Committee:** Provisional budgets were provided for council's review. A Finance Committee meeting is scheduled for January 11, 2010 at 6:30 PM.

**Killaloe & District Public Library Board:** Councillor O'Reilly reported that Mayor Visneskie was elected as the chair of the library board at their December meeting. The issue of having the internet service available from outside of the library on Sundays was discussed. Council agreed to this request.

**Other Committees:** Councillor Cybulski reported on his attendance at the Energy Opportunities Workshop. He advised that the trend seems to be moving towards solar panels rather than wind turbines as the panels are not as invasive, and the surplus energy that is produced can be sold back directly to Hydro One. The benefit of wood pellet production to the forestry industry in Renfrew County was also discussed.

Council took a short recess, and then reconvened with the same members present.
